



- The ability to extract time captured data in ClickSoftware (Verizon Field Force Manager) & import, via web services, manually or automatically into the Link-Sync solution, apply OT rules, submit/approve the time by users/supervisors, and allow for correcting/ modifying the time in Link-sync before migrating this data into your accounting/ payroll system or payroll providers. We integrate to most systems such as QB/QBO, Sage 50/100/300 (PeachTree, Timberline, MasterBuilder, MAS90), ADP, Paychex, Paylocity, PayCor, PayCom, etc. ORAC
- •The ability to push new jobs from accounting/job systems such as BullHorn, QB, QBO, Sage, etc. to allow for these new jobs to be pushed into ClickSoftware and dispatched out to the employees.

time-entry system in an automated fashion. So, as new jobs are added into the QB system they will automatically appear in the Time-Entry system without user intervention. This can be automated with others systems, as well, such as GreatPlains/Dynamics, Oracle, JDE, etc. whereby, a file is FTP'd/sFTP'd to the Skibo secure-servers that will automatically import into the Skibo web-hosted time-entry system.

- Will compute WorkMan's compensation with difficult calculations tied to unions that may be tied to cities/states the jobs are worked in.
- •*Prevailing wage rate calculations with complex calculations for automatic deductions, union dues, fringe benefits tied to specific unions based upon hours/days worked in a pay-period per job per union, etc.*
- •Tablets in the field can be used to directly enter data in to allow for submitting and approving time by others.
- Data from ClickSoftware or other systems can be imported into Skibo system for consolidation/calculation (s).

Piece Rate, Prevailing Wage Rate w/ Invoicing & Invoice Integration:

- Piece entry solution that allows direct entry of the quantity of pieces produced or routes delivered by employees into the Link-Sync system .
- •Allows the importing of time worked from time and labor then, compares & performs a prevailing wage rate calculation comparing pieces produced/routes delivered times a rate per piece and hours worked * an hourly rate. With the ability to pay the higher of the two.
- •Automated assigning of employee pay-rates based upon employee, job, task, phase, Customer, etc.
- •Ability to directly create invoices for cross billing of Customers for employees time and materials billing or pushing into systems such as QB/QBO invoice systems, etc.
- •Ability to generate a payroll output EPIP file for uploading directly into ADP, Paychex, Paylocity, Paycor, PayCom, etc. payroll system (s).
- •Salary allocation of a salary person's per pay-cycle pay amount to the jobs based upon hours worked percentage.
- State, City, County/Local withholding tax overrides by tying the job to the State, City, or County local code and overriding this variable when passing to payroll to allow for an employee to work on more than 1 job in more than 1 taxing jurisdiction and automatically override the variable when passing into payroll.
- •Flagging jobs as billable or not billable and passing accordingly into the Invoice system.
